The Role of a Panel Member



What is a GDC?

A 'GDC' is made up of a group of school governors who meet to review decisions made by the Headteacher about suspending or permanently excluding a pupil.

The purpose is to ensure that such decisions are fair, justified, and in line with school policies and legal requirements. The GDC reviews evidence, discusses the case, and decides whether to uphold or overturn the decision.



Why do we run GDC's

• The Governing Boards duty to consider an exclusion/suspension is outlined in the DFE Suspensions and Exclusions guidance, part seven. *Ref pages 35 – 38.*

"Governing boards have a key responsibility in considering whether excluded pupils should be reinstated. This forms part of their wider role to hold executive leaders to account for the lawful use of exclusion, in line with the duties set out in law, including equalities duties."

What is my role as a Governor?

- To read the 'pack' of information provided by the school on the suspension/permanent exclusion prior to the meeting.
- To attend the meeting in person or virtually and work will fellow members and clerk to complete the agenda. This will include opportunities for you to ask questions of anyone in attendance to gain assurance that the suspension/permanent exclusion is lawful, reasonable and procedurally fair.
- Working with fellow panel members, to deliberate all evidence heard from all parties and make a decision whether to 'uphold' or 'overturn' the suspension/permanent exclusion.


